





#### Abstract

This study aims to determine the governance of halal tourism in Lampung based on the Fatwa of the National Sharia Council (DSN) of the Indonesian Ulema Council (MUI) No 108/DSN-MUI/X/2016 concerning Tourism Improvement. The research method uses an empirical qualitative approach, as well as legal and doctrinal approaches. Data collection methods include observation, interviews, and literature study. The results of the analysis reveal two things. First, the management of halal tourism based on the DSN-MUI Fatwa consists of 11 (eleven) general provisions and 15 (fifteen) definitions. Four objects are the focus of general provisions, namely tourism, sharia tourism, tourism, and sharia tourist destinations. There are six subjects, namely tourists, sharia travel agencies, tour guides, tourism entrepreneurs, and
