#### ABSTRACT

Lexical meaning is the lowest meaning unit in a language's meaning system that can be separated from other comparable units. Contextual meaning is the meaning of a lexeme or word inside a context. A contextual definition is also a definition in which the term is used by embedding it in a larger expression containing its explanation. This research aims to find out : 1) What kind the lexical meanings are contained in a contextual sentence in the article of Chelsea FC – the 5<sup>th</sup> Stand application? 2) What are the contextual meanings used in the article of Chelsea FC – the 5<sup>th</sup> Stand application?

This research was descriptive qualitative because the data were the article in Chelsea  $FC - The 5^{th}$  Stand Application. There were some steps in collecting data such as download the application in play store or apple store, browsed thearticle in the application, read and find the contextual meaning and lexical meaning. In data analysis, this research used Miles and Huberman procedure, namely data reduction, data display and conclusion drawing/ verification. The researcher use validator to validity.

The result of this research werethe researcher analyzes the context of the sentences and determines the different lexical meanings that are present. The researcher found 5 contextual meanings contained in 5 articles in Chelsea FC - the 5th Stand Application. Based on this analysis, the researcher concluded that there are three categories of lexical meanings, namely lexicon, lexeme, and word. The researcher deduces the contextual meaning the speaker intended from this examination. Even though some of the words in the article have various meanings, others are readily guessed and misconstrued. The author's analysis, which sought to identify lexical meanings and their types as well as contextual and inarticle meanings, produced results that support the idea that grammar is used in everyday life and that language is learned from a variety of sources. In this case, the articles in Chelsea FC - The 5th Sand Application are very educational and much better for enhancing one's proficiency and competence in the target language.

#### CHAPTER 1 INTRODUCTION

#### A. Title Confirmation

This thesis title is "An Analysis of Lexical and Contextual Meaning in (Chelsea FC – The  $5^{th}$  Stand) Application". In the world of language, there are certainly lexical and contextual aspects that are difficult for readers to understand. Departing from this problem, the author is interested in conducting research that focuses on lexical and contextual analysis so that people can easily understand the lexical and contextual meaning of an article.

An analysis is a process that involves systematic testing of something to ascertain the relationship between its parts and its connection with the whole, in addition to being an activity to search for correlations.<sup>1</sup>The analysis is a multi-step process that consists of parsing, selecting an item to be classified or organized in accordance with defined criteria, and then interpreting and deducing its meaning.<sup>2</sup> An understanding analysis is a thinking activity to break down a whole into its component parts in order to identify the signs of the parts, their connections, and the significance that each component plays in the overall system.<sup>3</sup>

The referent, the findings of sensory observation, or the meaning that is actual in day-to-day living can all be used to determine the lexical meaning.<sup>4</sup>The terms lexical meaning and word meaning are interchangeable. When usage or context have no bearing on a word's meaning, it is said to have a lexical meaning, also known as an external or semantic meaning.<sup>5</sup>Because each definition in the dictionary serves as an illustration of lexical meaning, there will be a correlation between the lexical meaning and the dictionary.<sup>6</sup>

The outcome of statements and context is contextual meaning (situational meaning). As a result, the context contributes to the meaning.<sup>7</sup> The meaning of a word or phrase in relation to the circumstance, setting, and timing of its use is referred to as contextual meaning. The relationships between the words in a text, or, in certain situations, the relationship is found outside of the text, in the immediate situation, provide context.<sup>8</sup>

The article is a freelance writing work containing an opinion of someone who already knows a lot about an actual problem or object, to inform, entertain, influence, and convince the reader.

In understanding the information on clubs, matches, match results, press conferences for coaches and players, as well as video footage of training and match highlights, commonly the fans use Chelsea FC - The 5<sup>th</sup>Standapplication. #### **B.** Background of the Problem

Language learning and teaching are made possible by linguistics. Linguists, language instructors, translators, dictionaries, textbook authors, and anybody else who works with languages can benefit from linguistics. Everyone should take language development into consideration when studying linguistics, or the ability of individuals to successfully comprehend and apply the word, both verbally and in writing. One of the many subfields of linguistics is comparative linguistics. Other subfields include sociolinguistics, ethnolinguistics, psycholinguistics, semantics, pragmatics, syntax, and phonetics.<sup>9</sup>In this study, the researcher will focus especially on the lexical meaning and contextual meaning in the semantic field as the phenomenon.

According to Portner, semantics is concerned with how grammatical operations create complex meanings out of simpler ones; it concentrates on the literal meanings of words, phrases, and sentences. The study of pragmatics, which focuses on how language is used in specific contexts, tries to clarify how elements outside of language affect the literal and figurative meanings that speakers convey through their use of language.<sup>10</sup> There are various aspects of semantics, and the researcher chose lexical and contextual meanings as the foundation for this study.A word's contextual relationships determine its lexical meaning, which is how it is understood. Language has a context-dependent meaning or contextual meaning. The context's reference to human existence is relevant. the words take on context-specific meaning when people employ words that occasionally have various meanings from their true meanings.<sup>12</sup>

As a result, lexical analysis and contextual meaning can be used to discover where a language's meaning originated. However, miscommunications could happen when speech partners and speakers interact. This is because there are inconsistencies in the signals sent, resulting in a mismatch between the listener's interpretation and the speaker's use of language. The difference in reaction to meaning might arise because a word or sentence may have several meanings. Based on the researcher's experience, people, students from the researcher class and the general public in the vicinity of the researcherwho appreciate sports will typically look for information about their preferred sport through literature, such as in articles or journals from Chelsea – the 5<sup>th</sup> Stand Application. Their finding showedthat The Little Prince contains four different meanings, including metonymy, irony, and metaphor as lexical and contextual meanings. Irony emerged as the primary meaning among all of these. The author of the children's book intentionally used irony to convey a moral lesson to the readers, especially the young ones.Therefore, I will make comparing the Chelsea FC – the 5<sup>th</sup> Stand application.

Theresia Budi Sucihati writes in her journal, "An Analysis of Lexical and Contextual Meaning on Sports News in Jawa Pos Newspaper (Linguistics Study)," that her study focused on linguistics and investigated lexical and contextual meaning. Reading the news report can teach us how to appreciate literature and the history of the language. They concentrated their research on the lexical and contextual meanings used in sports stories as a result. This study used a descriptive qualitative method because the researcher would be evaluating and interpreting the object research of a sports article. Akhmad Ali Mirza writes in his journal "The Effects Of Contextual Meaning Aspects On Reading Comprehension" The researcher came to the following conclusions as a result of his investigation: (1) Reading proficiency has a significant impact on students' reading comprehension; (2) contextual meaning aspects (context clues) have a significant impact on students' reading

comprehension; and (3) neither reading proficiency nor contextual meaning aspects (context clues) have a significant impact on students' reading comprehension.

Umi Nur Chotimah and Agus Husein As Sabiq write in their journal "An Analysis on Contextual Meaning of Selected Songs in Rex Orange County's Album "Pony" and Its Pedagogical Implication" that The Pony album, in summary, contained numerous contextual implications. This album had 40 contextual meaning data and seven types of context, according to the researchers. One personal context datum, 11 situational context data, 2 purposeful context data, 6 mood context data, 6 temporal context data, 11 object context data, and 3 linguistic context data were distributed. The researchers, on the other hand, were unable to locate the remaining categories of context. As a result, the songwriter's usage of situational and object settings was more prominent in this record. Meanwhile, the setting in this study with the least number was personal. Rex used many contextually meaningful words, phrases, and sentences to describe his life tales, which we learn about through song lyrics.

Anna Riana Suryanti Tambunan, Winda Setia Sari, Citra Anggia Putri, Morada Tetty, Rita Hartati writes in their journal "Lexical And Contextual Meanings In Children Storybook: A Stylistic Approach" The researchers discovered that the fairytale The Little Prince, published by Antonie de Saint Exupery in 1943, contains a total of 2002 phrases, with 27 of them containing stylistic techniques based on contextual and lexical meaning. The study's problem is to use a stylistic method to discover the storybook's deeper significance. Examining the stylistic devices identified in the storybook as well as those found based on lexical and contextual meaning are the two objectives of the study.

After reading and comprehending the pertinent research, the researcher discovered that the general population is still experiencing issues. Between the study that has been conducted and the research being done, there are some similarities and contrasts. By updating prior findings, it encourages the researcher to carry out similar study.
